4.	Disposal of Claims and Objections	By 18.08.2018 (Saturday)
5.	Updation of Electoral Rolls	By 28.08.2018 (Tuesday)
6.	Final Publication of Electoral Rolls	04.09.2018 (Tuesday)


Electoral Registration Officers (EROs) concerned shall publish the draft municipal Electoral Rolls on 4th August, 2018 with a notice in Form-2 in accordance with the statutory Rules.

The applicants desirous of filing claims/objections may do so before ERO/AERO manually or by logging on <http://ceojk.nic.in/efiling> electronically.

Further,

- i. The place of hearing for the claims/objections received shall be the headquarters of Electoral Registration Officer (ERO)/Assistant Electoral Registration Officer (AERO);
- ii. The date of hearing for claims/objections shall be notified by the Electoral Registration Officer (ERO);
- iii. The notices giving abstract of the claims/objections received by the EROs shall be uploaded on a daily basis on the website of the Chief Electoral Officer, J&K as also the district website (<http://jammu.gov.in>);
- iv. the Electoral Registration Officer (ERO) shall pass an order on the claims/objections latest by 18.08.2018 and every such order shall be pasted on the notice board of the ERO immediately on such issuance;
- v. any appeal against the order passed by the ERO shall be made available within the prescribed statutory period of 5 days;

- vi. the Special Camps shall be held at the Polling Station level;
- vii. for any assistance in this behalf Electoral Registration Officer (ERO), the Assistant Electoral Registration Officer (ERO), or polling station level officers (PSLOs) of the concerned area may be contacted. The details of Electoral Registration Officer (EROs), Assistant Electoral Registration Officer (ERO), Polling Station Level Officer (PSLOs) are available in the office of the Deputy commissioner Jammu and also on the website of CEO, J&K www.ceojk.nic.in. The list of polling stations is also available on the said website.
